## MEMBERSHIP PRIVILEGES, RULES, AND REGULATIONS

All applicants are required to read, accept and abide by the terms and conditions described as follows:

- (1) DURATION OF MEMBERSHIP AND TYPE OF MEMBERSHIP
  - (a) Membership will be valid from **November 1, 2011 thru October 31, 2012**.
  - (b) Memberships will provide significant discounted rates at both **GOLF HOLLYWOOD!** Courses. Discounted rates may vary with the time of day or time of season.

  - (d) This Membership **requires** use of an electric golf cart and should **NOT** be considered by those who normally walk to play golf.
  - (e) Any actions by governmental, civil authority or acts of God effecting membership privileges shall not be deemed the responsibility of Golf Hollywood! Management.
- (2) STARTING TIMES/USE RESTRICTIONS
  - (a) Membership will be afforded the privilege of the earliest advanced tee times at each particular club. Tee times may be phoned in. Members abusing advance tee time privilege (i.e., no call, no show) may have their privileges suspended by management.
  - (b) The Director of Golf may, from time to time, reserve starting times for special events and tournaments. Membership abatement due to any future renovations will be the sole discretion of management.
- (3) CLUB POLICIES
  - (a) Members must abide and adhere to policies set forth by the management of each participating club. Persistent policy violation may result in Membership suspensions.
